General Data Protection Regulation (GDPR)

European Parliament has approved the European Commission proposal for the publication of the General Data Protection Regulation which has entered into force after the publication. This Regulation aims to protect and respect the fundamental rights and freedoms of natural persons with regard to the processing of personal data.

General Data Protection Regulation applies to organizations located within the European Union. Nevertheless, it also applies to organizations that are located outside of the European Union if they cooperate with EU data subjects, or offer goods and services to any EU member state.
